<b>Advantages of project implementation in FEZ</b>	<p><b>Tax on profits</b> – exemption of income derived from the sale of goods for export or to other residents of FEZ;</p> <p><b>Tax on immovable property</b> – exemption for 3 years from the date of registration in FEZ;</p> <p><b>Land tax</b> – exemption for the period of design and construction, but not more than 5 years from the date of registration. Exemption regardless of the mode of their use (for export sales and (or) to other FEZ residents);</p> <p><b>Customs preferences</b> – exemption from customs duties on raw materials and equipment imported to the territory of Free Custom Zone (FCZ defined for each resident individually). Exemption from customs duties on manufactured products being exported outside the Eurasian Economic Union.</p>
