ESTABLISHMENT OF STAMPED STEEL AND ALLOY RIMS PRODUCTION IN MOGILEV FEZ



ABOUT THE PROJECT

PROJECT AIM

The project involves the creation of stamped steel and alloy rims production in the territory of the FEZ Mogilev.

ADVANTAGES OF THE PROJECT

- The total capacity of market of car rims in the territory of the EAEU member countries in 2014 amounted to more than 25 million units.
- Over the forecast period, the market capacity of stamped steel rims for passenger cars will increase by 20% and amount to at least 30 million units.
- Despite the continued growth, the market of car rims in the EAEU countries is not sufficiently developed, which determines the demand for these products and creates favorable conditions for their export.
- Dynamically developing domestic automobile industry (CJSC "BELGEE", SP-ZAO Unison).

Estimated payback period	5-7 years
Advantages of project implementation in FEZ	<p>Tax on profits – exemption of income derived from the sale of goods for export or to other residents of FEZ;</p> <p>Tax on immovable property – exemption for 3 years from the date of registration in FEZ;</p> <p>Land tax – exemption for the period of design and construction, but not more than 5 years from the date of registration. Exemption regardless of the mode of their use (for export sales and (or) to other FEZ residents);</p> <p>Customs preferences – exemption from customs duties on raw materials and equipment imported to the territory of Free Custom Zone (FCZ defined for each resident individually). Exemption from customs duties on manufactured products being exported outside the Eurasian Economic Union.</p>
